Returning Families: Re-enrollment opens in December for the next school year. Early bird registration must be paid by February 15th. You can access your reenrollment packet through your Renweb Parent Portal.

New Families: Enrollment is a two step-process. The application is found on our website: www.clsabq.com - Click on the view more button and create a Renweb account. Follow the directions to complete the application. You will then receive an email with a link to proceed to the enrollment packet. Registration includes both the application, the enrollment packet, an educational success consultation, a shadow day or evaluation and the registration fee.

Tuition payments are collected through a company called FACTS. During the enrollment process, you will be asked to set up an automatic payment plan through your bank account.

Financial Aid: All families have access to needs-based financial aid through our FACTS program, based upon their individual situation. We want to make a Christian education possible for every family that believes in our values and vision. The congregation of Christ Lutheran Church has given out over \$100,000.00 in financial aid annually. You can apply through the website www.factsmgmt.com. You will be asked to upload your taxes, and also given a place to write a narrative and let us know why you are applying. There is a \$35 fee for the process. After you are verified, you will meet with a Financial Aid Committee to determine what financial aid may be available for you. **New and returning families need to apply for financial aid using their 2021 tax return at the time of their registration (you may upload your taxes when they are completed, but the financial aid application must be filled out in conjunction with your enrollment/reenrollment packet. Taxes must be uploaded by April 15th, so that financial aid meetings can take place in April and May. Financial Aid is not retroactive.**

Scholarships: There are some scholarships for tribal associations, and for lower income families available. Please see the school office for more information.
